

Power of Attorney How it works

The **power of attorney** is a written authentification that is required in some circumstances, and necessary:

- If you incorporate your company or a subsidiary at our French address
- If we may receive **certified letters** on your behalf

1- Your power of Attorney

Every power of attorney is valid for one person.

- You are
- Sole trader
- Micro-entrepreneur without business name
- Do
- A personal power of attorney

- Company or Entity
- Non-profit organization
- Micro-entrepreneur with business name
- A personal power of attorney
- Then a business power of attorney

There are several ways to establish this Power of Attorney called « Procuration Postale ».

1.1- In a French Post Office

You can go to any French Post Office with a passport and a recent KBIS (The French certificate of a company incorporation). It's a free administrative task that the post agent will do for you. Please ask for a « **Procuration Postale ».**

Personal power of attorney

The power of attorney has to be assigned to:

Business power of attorney

The power of attorney has to be assigned to : $\label{eq:GLOBE SERVICES} \textbf{GLOBE SERVICES}$

Just indicate to the post officer this name and the number SIRET: 482 906 294 00053

→ **The power of attorney** will be printed immediatly – you can upload it on line through your French-Office personal access

1.2- On line (ONLY if you live in France and you are a micro-entrepreneur or a profession libérale)

Through the French Post web site, you can create a « procuration Postale » if you speak French. They will require your ID proof and your French residency proof.

Within 3 days, you receive a confirmation of your request and you can retrieve your « Procuration number » via the French Post web site.

→ Then inform us with this number by entering it in your personal French-Office access

1.3- From abroad

If you are abroad, you have different possibilities:

- Establish the power of attorney in a French Ambassy
- Establish the power of attorney with a notary or a lawyer it's the easiest way
- Wait for a journey to France to go to any post office and do the « procuration postale »
 - → Use the below template with your legal representative if you don't do the «procuration postale » in a French Post office

2- Inform us about your power of attorney

You can forward your power of attorney :

BY UPLOADING: In your online accesss (« My data/My documents »)

BY POST: French-Office - Registration service
